# About YHAI

**Youth Hostels Association of India, YHAI**, an ISO 9001-2015 Certified Organization and a society registered under the Societies Registration Act, 1860. It has 26 State Branches and more than 250 Units at District level in all over the Country. YHAI is a membership based organisation and having more than 1.5 lac life members and around 40000 annual, bi-annual members and more than 250+ institutional members. It is affiliated to Hostelling International (HI) which is having 89 member countries and 3600 Youth Hostels all over the World.

YHAI is engaged into different activities to encourage youth travel and to provide low cost good quality accommodation. YHAI is organising various adventure activities with “No profit No loss” motive and continuously strives and organize events to protect the environment. YHAI is in the field of Trekking since 1975 and organising the adventure activities. It was started initially with the meager number of 200 participants in Kishtwar in Jammu and Kashmir which touched in tens of thousands now and is also organised in almost all States of India and offering young people of limited means to acquire greater knowledge and care of the country side.

## Be a Facilitator & get Rewarded

Facilitator will be engaged by YHAI to influence the minds of the people to book a programme with YHAI. His/Her aim will be to generate bookings in the programmes of YHAI. He/She will be engaged and officiated at District, State and National level of the YHAI. He/She will work in liaison with the Unit and State Branch in their respective areas under intimation to YHAI.

Facilitator will be given reward of the participation fee on each participant of the programmes which will be announced by YHAI as “Reward on Bookings”. All such bookings will be through offline mode only.

He/She will not get reward on the bookings of every programme.

The Scheme will not be applicable on Membership Generation or Renewal.

The Facilitator may organize local seminars from time to time without financial involvement for promotion of YHAI activities and for generating the Bookings.

# ROLES AND RESPONSIBILITIES & Terms and Conditions for Facilitator

- A) The Facilitator will be engaged by YHAI through an agreement at District, State level and National Level.
- B) The Facilitator will contact the Institutions/Organizations/Schools/ Colleges/Offices for the promotion of YHAI and its activities. Facilitator will not be authorized to commit/sign any document or agreement on behalf of YHAI with them. If such case arises, Facilitator has to contact YHAI immediately and YHAI will do the same itself.
- C) The Facilitator will be eligible for reward on minimum of 10 bookings.
- D) The Facilitator will not be the employee of YHAI and will not be entitled to any Incentives/Salary/Insurance/ reimbursement or any other perks and benefits from YHAI.
- E) The Facilitator will not be entitled to any reward in case the programmes are cancelled either by the participants or by YHAI on account of unforeseen eventualities/force-majeure.
- F) The Facilitator shall not handle cash in any manner of the programme fees. All the transactions must be through YHAI's official accounts.
- G) The Facilitator will not receive/any claim, additional charge/commission except the participation fee of the programme from the participants as prescribed by YHAI.
- H) YHAI will allot a code number to each Facilitator, that would be mentioned on each registration form and to be counter-signed by the Facilitator himself/herself.
- I) YHAI will manage and create a separate code in the software and register them according to allotted code number. Accordingly, their reward will be calculated.
- J) YHAI will be providing the training to the Facilitator about the YHAI and its activities. The limitations of the Facilitator will informed during the training.
- K) YHAI will set the target of bookings for a year. In case, Facilitator will be given substantially more than targeted bookings, he/she will be given complimentary participation in Family Camp programme with spouse and two children once in a year.
- L) YHAI will not be held responsible in case of misappropriation of funds/ misinformation/ misinterpretation/fraud done by Facilitator.
- M) The Facilitator has to report the numbers of participants on the monthly basis and submit its report in stipulated timeline as prescribed by YHAI on 5<sup>th</sup> day of every month.
- N) The reward will be distributed after the completion of the programme and Facilitator will submit the invoice before in time and the award amount will be directly transfer to the bank account of the Facilitator.
